The Owner hereby agrees to maintain the side sewer constructed under this permit in accordance with the rules and regulations of the City of Mercer Island and, further, will permit access with entry by authorized representatives of the City of Mercer Island on the property described in this permit at any reasonable time for the purpose of inspection for compliance with all City regulations.
- 4. The Owner is hereby expressly notified that the City of Mercer Island sewerage system is a sanitary sewer system and he agrees that he will not, at any time, connect storm water drainage from any source to the City's system; this includes, but is not limited to, the following:
 - (a) Roof Downspouts (b) Building Footing Drains (c) Springs (d) Any Ground or Surface Water Drains
- 5. The Owner and his Contractor hereby agree to accept full responsibility, and to hold the City of Mercer Island harmless for any liability, damage and/or costs which may accrue from prosecution of the side sewer construction and any work accomplished under this permit.
- 6. The Owner and/or his Contractor hereby agree to safeguard the work done under this permit in such a manner as to prevent injury and/or damage to the public. Such precautions shall include the employment of all necessary ditch safeguards such as lanterns, barricades and safe access or egress through the working area.
- 7. The Owner and his Contractor agree that all street cleanup and road restoration will be made to the satisfaction of the City of Mercer Island.
- 8. The Owner and Contractor agree to obtain, at no cost or liability to the City, any other permits for construction work to be accomplished under this permit.
