1. The address of my property is 4533 90<sup>th</sup> AVE SE, Mercer Island and we are applying for a permit to build an accessory dwelling unit at this address.

7. I agree to have this document recorded with the King County Department of Records at my expense, and supply a copy to the City of Mercer Island.


