John,

We do believe this to be an emergency situation that requires immediate attention. We will retain this email thread as authorization to remove the three trees in question (509, 510, and 511) immediately.

As opposed to responding within two weeks with the code information requested below, we would instead prefer to simply remove our request/application for a non-development tree permit. We consider the appropriate information regarding the removal of these trees to have already been submitted via our building permit application (2209-088); which includes a complete arborist report, Geotech report, site plan, demo/tree removal plan along with all other construction documents associated with the project.

This should be an emergency tree removal associated with the building permit, not a non-development tree permit. The only purpose for the non-development tree permit was to remove the trees earlier, which is now handled via emergency approval.

Ruji,

We are running into some serious red tape (see thread below) just trying to follow up on your request to remove three trees that are impacting the repair/function of the drainage line (located within the easement that runs diagonally through the site). I know you've discussed this issue with Mike Burke many times. I've attached our tree removal plan and now our Geotech report for your quick reference.

Submitting for the non-development tree permit was our attempt to address this repair now, as opposed to later. We all know this will eventually be tied to development, as we are already submitted for permit to tear down the existing house and build a new one. I see below that John mentions we can simply wait for his review on the building permit (he is scheduled to review this project next week), but we all know this permit won't be ready for some time. We certainly expect rounds of revisions and the necessary time that it takes to compile a response and re-review. In this same effort to expedite this drainage repair, we recently obtained a permit to remove the detached garage (to theoretically be replaced later with a carport) which has as its sole purpose the ability to provide an access path for equipment for this repair. We are clearly never going to build a new carport here. Please note that this strategy was suggested to us by Tim McHarg.

If the removal of these trees must be tied to development, can we just tie it to our existing permit to remove the carport (2204-083)? That permit is in hand, and active.

Matt,

I should have caught this before, but the entire property is in a potential landslide area. That was my mistake to not let you know sooner. Since it is within that area the non development tree code 19.10.050 is triggered. It may be easier to wait for development and have your geotechnical professional address this at that time. Or you can do it now. I will be reviewing your building permit next week if you want to wait.

- B. Tree removal that is not associated with a development proposal located within wetlands, watercourses, landslide hazard areas and buffers associated with these critical area types shall be permitted subject to the following standards:
- 2. A restoration plan prepared by a qualified professional is submitted that contains the following:
- a. Analysis demonstrating how the ecological functions and values including but not limited to slope stabilization (Engineering geologist or geotechnical engineer), hydrologic function, and habitat value are being preserved by the proposed plan.
- b. Proposed removal of all noxious weeds, as defined in chapter 19.16 MICC.
- c. Removed trees shown as made into snags at a safe height, where feasible.
- 3. Implementation of approved restoration plans shall be completed by a qualified professional.
