I, Ananta S. Gudipaty, am over the age of 21 years, and make the statements herein of actual knowledge.

1. The address of my property is 3632 90th Ave SE, Mercer Island and we are applying for a permit to build an accessory dwelling unit at this address.
2. I own this property and I and/or someone in my immediate family will make my/their legal residence in the principal dwelling or accessory dwelling unit and actually reside in such dwelling for more than six (6) months per year.
