7. I agree to have this document recorded with the King County Department of Records at my expense, and supply a copy to the City of Mercer Island.

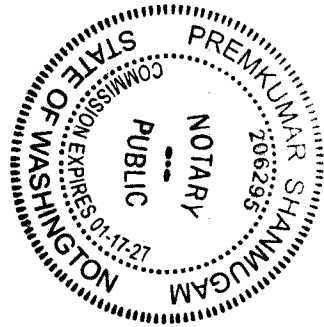

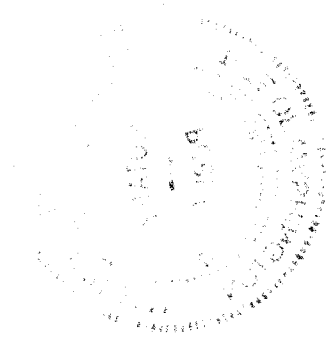
