Mr. Galt,

The City strenuously objects to the Appellant's most recent request for postponement, which comes as a result of a long pattern of delay by the Appellant in this proceeding. The stay in this code enforcement appeal, initiated originally in 2019, expired **June 30**, **2021**. Despite the fact that this appeal has been pending for nine months (and that other appeals have been filed, heard before this Examiner, and concluded within that period of time), Appellant now requests yet another postponement. To date, Appellant has requested extensions and/or hearing continuances on the following dates:

- -October 18, 2021
- -October 27, 2021
- -November 1, 2021
- -November 9, 2021
- -November 10, 2021
- -January 17, 2022
- -March 28, 2022

Further, the given basis for the continuance request is without merit and Appellant has failed to demonstrate good cause to support his request (as is required by ROP 416). The City, as well as yourself, have informed Appellant on numerous occasions that the Public Records Act is not a method for obtaining discovery in his code enforcement appeal and that you, as the Hearing Examiner, lack any jurisdiction over PRA matters. Notwithstanding that fact, the City has responded to Appellant's requests and provided him with a plethora of documents and files. It is abundantly clear that no amount of documents will satisfy Appellant and this is merely a stall tactic used by Appellant in continuing to avoid his obligations to complete the appeal proceeding that he himself initiated.

Should Appellant not wish to prosecute his appeal, he has the option to dismiss it. However, he should not be permitted to effectuate further delay for purposes of prejudice to the City's position. Again, this case has been pending since 2019 and each and every delay harms the City's ability to prosecute its case, as has been previously noted by the Hearing Examiner.

Finally, the City will be prepared tomorrow to address the inadmissibility of Mr. Miller's late submitted exhibits, noting that under the Hearing Examiner's rules, Appellant's exhibits and any briefing were due on November 12, 2021, over four months ago (and that indeed, the Hearing Examiner granted a continuance to Appellant for submitting his materials to November 15, 2021).


