6. I note that with respect to the payment receipt, the “due date” for appeals fees shown on these types of invoices reflects the date paid, not necessarily the accurate due date for appeals fee. This is because Appellants used the City’s online payment portal to make payment, as opposed to dropping off a check to City Hall, which the City also accepts as a way to make payment for appeals per MICC 19.15.130.
