I was walking my dog, Merlin, a miniature dachshund on leash on the opposite side of the street from this house. We take this walk in our neighborhood every morning. The dog that bit me was on their deck which faces the street. The dog is often outside on the deck and always barks and lunges toward us from the deck. The male owner, I believe his name is Brent, came out on the deck. My previous contact has been with his wife, Molly. Next thing I knew, the dog had come down from the deck and ran out of their yard (there is an invisible fence), across their driveway, straight over to me (off leash) and bit me on the leg. I picked up my dog and the dog that bit me stayed in the area, barking. I started screaming. I was in pain and scared, This is the second time that this dog bit me. I filed a report last summer as well. This bite was worse. The owner came out and held his dog back and we talked a little. I pulled up my pants and showed him the bite on my leg. It was bleeding. I was in pain and upset so came home. We called 911-aid car came and said I did not need stitches but should see a doctor. Police filed a report. I saw a doctor the next day who prescribed antibiotics and gave me a tetanus shot. The bite inflicted a 3 inch long laceration and significant bruising. Again, please note this is the second time the dog was unrestrained and rushed at me and my dog and bit me in my neighborhood. I want to feel safe walking my dog in my own neighborhood.
