a) Resume Experience: Officer Shepherd has served as an Animal Control Officer in King County since March of 2022. Previously, she served as an Animal Control Officer with Oklahoma City Animal Welfare from January 2021 to February 2022.

Officer Shepherd completed the Washington State Animal Control Academy (80 hours of coursework and hands on training) through the Criminal Justice Training Commission in 2023. She has also completed training through Code 3 Associates for Equine Investigations. Additional training has been completed through the Justice Clearinghouse and certificates received for crime scene analysis, joint responses between law enforcement officers and animal law enforcement officers and building an animal welfare case. Officer Shepherd also received a certificate for Body Condition Scoring Animals from Pasado’s Safe Haven. Officer Shepherd has also received extensive continuing education in case articulation, lesion identification, leadership, and crisis intervention.

Officer Shepherd earned her Bachelor of Science in Animal Sciences and Management from Washington State University and graduated with her degree in 2020.

As an Animal Control Officer, Officer Shepherd has conducted and assisted in numerous animal cruelty and dog bite investigations. She has served and assisted with multiple search warrants and has compiled and forwarded numerous cases to the Prosecuting Attorney’s Office for review.

b) Subject of Testimony: Officer Shepherd is expected to testify as to her investigation regarding the incident between the dog “Buster” Greenfield and Ms. Maria Toro, as well as the results of that investigation. Officer Shepherd may also testify as to possible reactions following a dog bite based upon her experience and training as an animal control officer.

c) Basis of Testimony: Officer Shepherd will generally rely upon her educational credentials, her training and experience as an animal control officer, her review and investigation of the incident between Buster and Ms. Toro, and associated documents and materials relating to this case, and interviews with Ms. Toro, as well as “Buster’s” owners.


