I print out the quarantine paperwork prior to my arrival, I knocked on the door, a woman answered the door. I introduced myself and asked if she was Tamara, she said she was. I explained why I was there, she didn't think the driver was bite, they said they were fine, but were rubbing their shin. She said most of the delivery drivers drop packages at the end of the walkway, and some give the dog "Tucker" treats. She said he hasn't bitten before. She does have a ring camera and will look at the video. I asked her to send it to my if she had any footage.

Tamara will license the dogs and email me the dogs rabies vaccine information .

I called the victim and let them know the dog had a three-year rabies vaccine, that had expired in May. I explained the quarantine paperwork had also been issued to the dog owner.

I texted Tamara, she did not have footage of the incident.
