Good morning,

It would seem that the determination of whether the rockeries are illegal nonconforming is the main issue? Who makes that official determination? I also thought based on the meeting we had to discuss the west rockery stability, that the original grade issue would be resolved before their resubmittal. How did that get resolved, i.e., I didn't see any change in elevations in their design—or did I miss something—I look at finished floor elevations—not the top of the structure.

If the rockeries are illegal nonconforming and that means that they need to be removed, then that would change all the grading and I would request a review of that. That would also mean that whatever wall proposed would have to conform to the side and front yard retaining wall max heights —which may not work for the current grades? This would likely change a lot of things for this project.

From a geotechnical perspective, what is currently proposed is approved. What is allowed based on the code with respect to illegal nonconforming, etc.--- I won't be much help with.

Happy to discuss further if you think that would be helpful.

I see that both of you have approved your reviews for this permit, but wanted to bring this to your attention and get your thoughts because this permit is still getting a lot of attention from neighbors.

Kevin – I am looping you in on this because a portion of the lower rockery is in the ROW. I see that they are going to be removing the upper rockery and replacing with a wall, but they are planning to leave the lower rockery as is.

If Dan's timeline is correct, this would mean that the lower rockery is illegally nonconforming and per MICC 19.01.050(3) Structures, sites and uses that were not in conformance with all applicable

code provisions in effect at the time of their creation are illegal and shall be brought into compliance with all applicable provisions of this Code.
