Background

City Councilmember Lisa Anderl proposed that existing parks and open spaces be included in a new land use designation entitled "Parks Zone." The Parks Commission has made recommendations regarding the Parks Zone, consistent with the PROS plan, and city staff have prepared material that the Planning Commission is reviewing for the legislation. These lands are currently zoned under residential, commercial, or public institutions, implying different development standards.

By grouping them under their unique zoning code, all parks and open spaces will have development regulations consistent with their intended use.

While this process will unfold over the next few months, the Planning Commission held its initial review of a proposed regulation written by City staff at its meeting on 1/24/24.
