




RIOT GAMES ELEVATIONS- SIGN 2





Manufacture and Install (1) Exterior single faced non-illuminated logo cabinet sign.

- Oval cabinet to be aluminum construction painted Red to match PMS#185c (satin finish).
- **3** Sign face to be .125" aluminum painted Red to match PMS#185c (satin finish).
- Sign returns to be .125" aluminum painted Red to match PMS#185c (satin finish).
- , Graphics to be cut-out of 1/2" thick acrylic painted White (satin finish).
- Attach Sign cabinet flush to wall with 1 1/2" x 1 1/2" x 1/4" angle frame painted Red to match PMS#185c (satin finish). (4) 3/8" lag bolts. Seal all wall penetrations with heavy duty all weather silicone-clear.






