- (7) Monthly Water, Sanitary Sewer and Storm & Surface Water Capital Recovery Charges for up to a ten-year period, as authorized by Sections 24.02.275, 24.04.275 and 24.06.275, respectively, of the Bellevue City Code, and as those sections may be amended or succeeded. These charges apply to properties connecting to the respective utilities after December 31, 1996.
- (8) Water, Sanitary Sewer and Storm & Surface Water Direct Facility Charges, as authorized by Sections 24.02.050B, 24.04.050B and 24.06.050B, respectively, of the Bellevue City Code, and as those sections may be amended or succeeded. These one-time charges are due upon initial connection of the property to the respective utility systems.
- (9) Such other water, sanitary sewer or storm & surface water charges that the City of Bellevue may hereafter lawfully impose.


