PROPERTY DESCR PTION: LOTS 17, 16, 15 and the southerly 60 feet of lot 14, Lakeholm Addition, together with shorelands adjacent.

EASEMENT: An undefined easement on shorelands of lot 17 for con-struction of a 6 foot wide by 48 foot long boat dock for the purpose of perpetually servicing the nearby sewage pumping station, with the shore end of the dock located approximately 70 feet northeast of the most southerly corner of lot 17. Dock shall become the property of the grantors upon completion of the dock.
