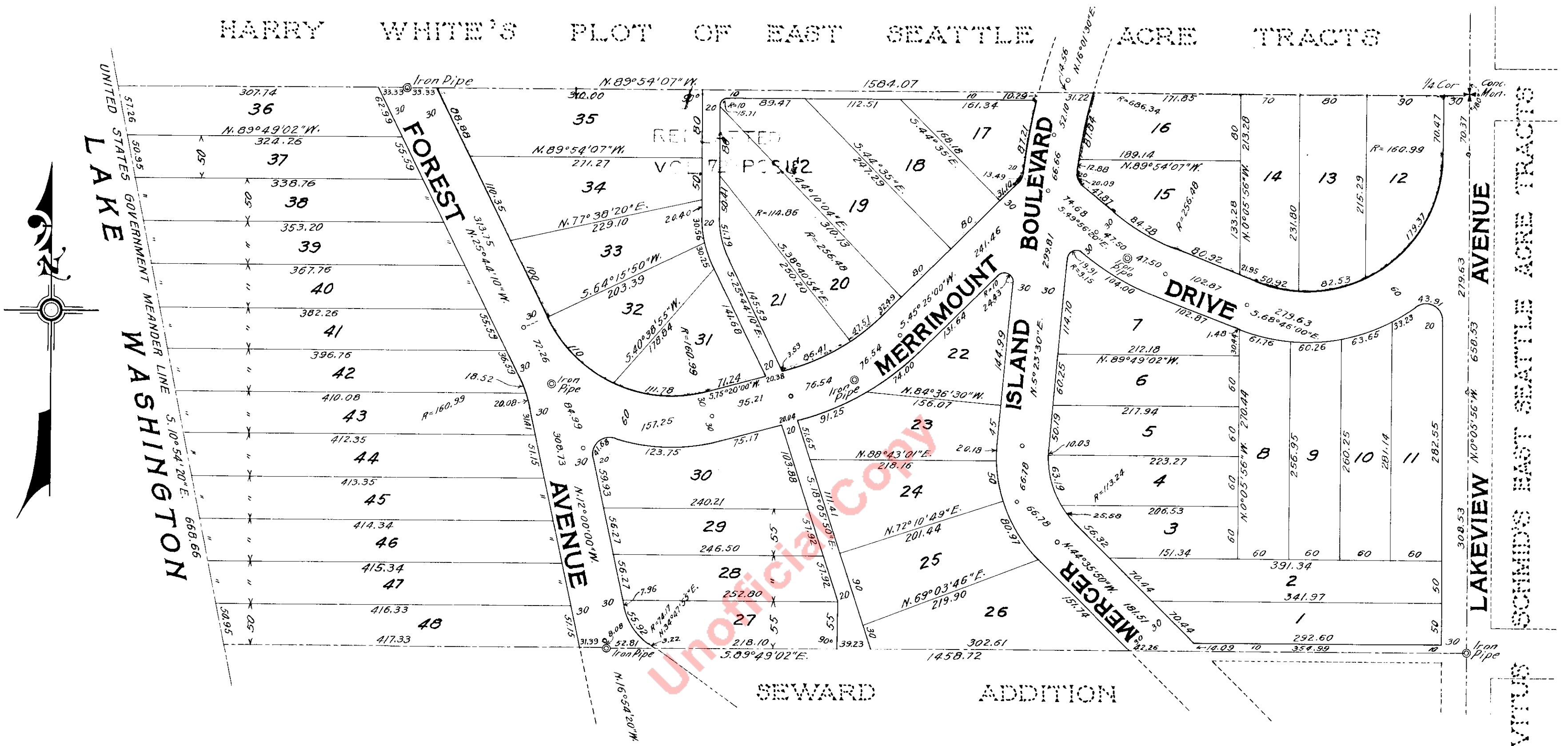


MERRIMOUNT ADDITION

DESCRIPTION

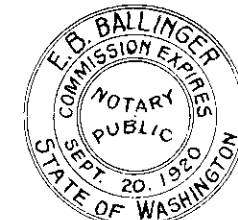
