The seller hereby grants to the purchaser, his heirs and assigns, an easement for ingress and agress to and from the tract hereby conveyed over, upon and across all existing roads on the south 100 feet of the portion of the northwest quarter of southeast quarter and the north 500 feet of the portion of the southwest quarter of the southeast marter of said section 18 lying easterly of Mercer Island Boulevard. The seller hereby reserves for itself, its successors and assigns, and for any owner of any portion of the south 100 feet of government lot 2 and the north 500 feet of government lot 3 of said section 18, a similar easement over all said existing roads over, upon and across said portions of said northwest quarter of southeast quarter and said southwest quarter of southeast quartér.

The above described property is subject to the following restrictions:

That said premises shall be used for residential purposes only and no commercial enterprises of any type or kind shall be maintained thereon. "lso, that neither said premises, nor any interest therein shall at any time be leased, sold, devised, or conveyed to, or inherited by or otherwise acquired by, become the property of, used or occupied by any person other than one of the White or Caucasian Race, provided however, that persons not of the White or Eaucasian Race may be kept thereon by such Caucasian occupany strictly in the capacity of servants of such occupants

The breach of any of the foregoing conditions shall cause said premises, together with the appurtenances thereto belonging, to be forfeited to and revert to the seller, its successors and assigns, each of whom shall have the right to immediate entry upon . said premises in the event of such breach, and the Purchaser upon violation of any of the foregoing clauses agrees to peaceably surrender the premises and give a good and sufficient deed to seller. As to the owner and his successors in interest of any lot or lots in said Addition all and singular, the said conditions and obligations are and shall be, and are hereby made covenants running with the land and a breach of any of said conditions or obligations may be enjoined, abated or remedied by the appropriate proceedings maintained by any of such owners in said Addition or their successors in interest

The Grantor for itself and for its successors and assigns does by these presents expressly limit the covenants of this deed to those herein expressed, and excludes all covenants arising or to arise by statutory or by, through or under said Grantor and not otherwise, it will forever warrant and defend the said described real estate.
