

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist

Governmental agencies use this checklist to help determine whether the environmental impacts of your proposal are significant. As noted, the property consists of what was three adjacent parcels, including two parcels with single family residences and piers, and one lakeshore easement parcel. The existing piers are used for private residential purposes. One similar residential pier exists to the east of the action area and many similar residential piers with boats exist to the west of the project area. A rip rap bulkhead backed by quarry spalls extends along the shoreline between the two piers.
