Hello,

To comply with MICC 19.06.040(B)(1)(d), the proposed tower would need to be located on the I-90 side of the retaining wall and not extend above the height of the wall. If you would like relief from these standards, you can apply for a Variance under MICC 19.06.110(B)(2). Variances require multiple rounds of public notice and involve a public hearing with the Hearing Examiner, who is the final decision authority.

Alternatively, you could propose to collocate the antennas onto the existing nearby towers. Applications to collocate equipment onto an existing facility are processed as 6409 eligible facility requests.

It doesn't seem to make a lot of sense, considering there are already facilities closer than 300'. Is there any sort of an exception/adjustment process? The other option is to 6409 the existing posts and put antennas on top of the existing antenna facilities.

Installing the antennas on the west side of the wall is not prohibited under the Mercer Island City Code. However, MICC 19.06.040(B)(1)(d) states that WCFs shall be at least 300 feet from any single-family dwelling, unless located between and below the top of the retaining walls in the traffic corridor. The proposed location not between the retaining walls in the I-90 corridor and is within 300 feet of several single-family dwelling, so it is not compliant with MICC 19.06.040(B)(1)(d).
