RE: Request for Minor Modification to Existing Wireless Facility – Section 6409 Site Address: ROW near 8215 SE 78<sup>th</sup> Street MIV 43

**Dear Reviewing Parties:** 

Crown Castle proposes to modify an existing small cell facility located in the public right-of-way adjacent to 8215 SE 78<sup>th</sup> Street (zoning designation P).

As part of the proposed modification the exiting wireless equipment will be removed.

In place of the removed equipment, (2) pole top panel antennas and associated radio equipment will be installed on the same existing pole top extension. Ancillary equipment will be concealed within the existing equipment shroud at 13' AGL. No modifications to the cabinet or equipment within are proposed.

Please note that minor modifications were previously approved under WCF22-011. No modifications have been installed under that approval. Technical considerations for customer coverage objectives have necessitate a project re-design, and a new approval is being requested.

This request is being submitted as an eligible facilities request for a minor modification under Section 6409<sup>1</sup> and the rules of the Federal Communications Commission ("FCC").<sup>2</sup> The following items are being included as part of this application package:
