The proposal is make minor amendments to Title 19, the city's development regulations (code), including: Clarifying side yard width standards, updating the allowed height of hardscape and driveway improvements, establishing a measurement method for height calculations in the MF,

PBZ, C, and B zones, and clarifying the definition of the term "lot coverage". The amendments are not intended to reflect substantive changes to the development regulations.

Mercer Island contains a relatively flat plateau ringed by steep slopes that reach to the Lake Washington shoreline.

b. What is the steepest slope on the site (approximate percent slope)?

There are portions of the east side of Mercer Island with slopes of approximately 85%.

c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? If you know the classification of agricultural soils, specify them and note any agricultural land of long-term commercial significance and whether the proposal results in removing any of these soils.

Soils found on Mercer Island include: Peat, Lake deposits, Fan deposits, Alluvium, Vashon recessional outwash deposits, Vashon recessional lacustrine deposits, Vashon recessional course-grained lacustrine deposits, Vashon ice-contact deposits, Vashon subglacial till, Vashon advance outwash, Lawton Clay, Pre-Fraser nonglacial deposits, Olympia beds, Pre-Olympia fine-grained deposits, Pre-Olympia coarse-grained deposits, Pre-Olympia glacial deposits, Pre-Olympia coarse-grained glacial deposits, Pre-Olympia fine-grained glacial deposits, Pre-Olympia glacial till, Pre-Olympia glacial diamict, Pre-Olympia nonglacial deposits, Pre-Olympia coarse-grained nonglacial deposits, and Pre-Olympia fine-grained nonglacial deposits.

No removal of soils is proposed.

d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.

Yes, approximately 50% of Mercer Island is defined as Landslide Hazard Area, generally in areas adjacent to Lake Washington and on sloped portions of the city.

e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.

The proposed code updates would not result in any filling, excavation, nor grading.

The proposed code update would not result in any clearing, construction or new uses.

The proposed code updates would not result in any impervious surface coverage.

Potential impacts to the earth will be addressed at the permit review phase of future development.

Yes, Mercer Island contains wetlands, streams, and is surrounded by Lake Washington.

The proposed code update will not result in the removal of any vegetation.

There are currently no threatened or endangered species known to be within Mercer Island.

The proposed code update will not modify any landscaping.

Mercer Island contains areas of knotweed, English ivy, and Himalayan blackberry; other noxious weeds and invasive species may be present on the island.

Mercer Island contains animal species typical of suburban development in the Puget Sound region, including but not limited to American crows, Stellar's Jays, Bald eagles, songbirds, deer, rats, and salmon. There have also been sightings of band-tailed pigeons, pileated woodpeckers, and cavity-nesting ducks.

b. List any threatened and endangered species known to be on or near the site.

There are currently no threatened or endangered species known to be within Mercer Island.

c. Is the site part of a migration route? If so, explain.

The area is within the Pacific Flyway.

d. Proposed measures to preserve or enhance wildlife, if any:

The proposal designates bald eagles as a species of local concern and would require a wildlife habitat assessment when any species on WDFW's Priority Habitats and Species list or bald eagle is found on a site where development is proposed. Impacts to habitat where wetlands and watercourses are also present would need to be mitigated.

e. List any invasive animal species known to be on or near the site.

Invasive animal species on Mercer Island include starlings and rats.

6. Energy and Natural Resources

The proposed code update does not require energy to be completed.

The city contains 16 sites listed as "awaiting cleanup" or "cleanup started" by the Dept. of Ecology's Toxics Cleanup Program.

The contaminated sites will not affect the proposed code update.

The proposed code update contains provisions to protect critical aquifer recharge areas from toxic chemicals.

The city contains existing single family residences, commercial and institutional buildings, wireless facilities, piers and docks, and associated appurtenances.

The proposed code update will not cause any structures to be demolished.

The city contains residential, commercial, and public institution zones

Comprehensive plan designations include residential, commercial, and public institution uses.

Shoreline Master Program designations for the city include urban residential and urban park.
