Requested action: The Planning Commission will hold a public hearing on proposed amendments to the Mercer Island City Code (MICC) to update the Town Center Retail requirements in MICC 19.11.020 and revise the relevant definitions in MICC 19.16.

Party Proposing the Amendment: City staff

Location of Property: Town Center

SEPA Compliance: A SEPA review is underway and a determination will be issued at least 60 days in advance of final action on this matter.

Public comment is accepted and considered by the Planning Commission and/or City Council through the legislative review process. Only those persons who submit written comments or participate at the public hearing will be parties of record; only parties of record will have the right to appeal.

Public Hearing, Public Meeting and Public Comment: The Planning Commission will review the proposed code amendments at their special meeting scheduled to start at **6:00 p.m. on Wednesday, February 16, 2022**. The meeting will be held virtually using video conferencing technology provided by Zoom, and the public will have the opportunity to comment during the public hearing by either calling in or logging onto the meeting as a Zoom attendee. Written comments will also be accepted until the public hearing is closed. Detailed instructions on how to comment live during the public hearing

An appeal of a legislative action is filed with the Central Puget Sound Growth Management Hearings Board pursuant to RCW 36.70A.280. There is a 180-day timeline controlling the appeal.
