- 5. I require time to review WITH MY ATTORNEY the 13 emails and estimated thousands of pages of documents
  6. Lwas very clear with the City that I required these documents long ago and absolutely no
  - I was very clear with the City that I required these documents long ago and absolutely no later than last Friday October 29
  - Recall at the hearing on October 28, I had predicted the City would deliver to me these documents after the last possible time when I would be able to use them, which was on Friday October 29
  - 8. I work full time during Monday through Friday and will be taking my daughters to an out of town basketball tournament this weekend
  - As a result, I do not have any available time to review these documents or to review and discuss these documents with my attorney between now and when my documents are due to be submitted.
  - 10. There is absolutely no chance that I will be able to prepare anything using the documents disclosed today.
  - 11. I sent many emails on Friday October 29 explaining that the records received today had to be received by Friday October 29 in order to be reviewable by me and my attorney in advance of the deadlines.
  - I received zero documents on Friday October 29, zero documents on Saturday October 30 and zero documents on October 31
  - I had CC'd Mr. Hearing Examiner on some, but not all, of the emails that I had sent on Friday October 29.
  - 14. Mr. Hearing Examiner responded by asking that I stop CC'ing Mr. Hearing Examiner on emails related to attempts at securing the documents via records requests
  - 15. Mercer Island City Manager, Ms. Jesse Bon, made promises via email on August 23, 2021 that information would be provided to me "expedited" by City Attorney, Mr. Bio Park. It wasn't until today November 1, 2021 more than 2 months after the promise via email that possibly some or all of the records were produced. More than 2 months would not qualify as "expedited"
- 16. Records previously obtained included improper redactions. E.g. an email from Ms. Jimmi Serfling to Mr. Travis Saunders was improperly redacted claiming attorney-client privilege REQUEST FOR CONTINUANCE - Page 2 of 11

communication. Neither Ms. Serfling nor Mr. Saunders are attorneys, and therefore neither could have been giving the other legal advice. I strongly believe the City improperly redacted that and other communications solely because they did not want me to see communication. This is illegal.

- 17. I had previously found documents that were unable to be open due to what appeared to be corrupted files, which had to be remedied by a City Paralegal Staff Employee.
- 18. Note I have not yet reviewed the estimated thousands of pages dumped on me / my inbox during today, but it is my expectation based on the pattern of problems witnessed thus far that there will be many missing, improperly redacted, and corrupted or otherwise unable to be open documents among the masses of many documents.
- 19. It was improper of the City to send a Voluntary Compliance Settlement Agreement that says it had expired on or about October 22 weeks in advance of having first produced the records in its possession that were needed to order to assess the merits of the VCSA.
- 20. The Attorney reviewing the VCSA has asked to see the document dump received today prior to her providing legal advice and opinion as to whether the VCSA should be considered, negotiated or accepted.
- 21. It has been very nearly 4 years since this matter began on or about February 2, 2018. The City had waited approximately 20 months to eventually issue the NOV and did so under entirely different staff, i.e. only after Mr. Anthony Myers replaced Ms. Jimmi Serfling.
- 22. There will not be any harm from a small delay in order to allow review of the documents received today; however, there would be great harm to my ability to prepare and defend and prevail in the case should a small delay not be granted at this time based on the facts and circumstances presented herein and known to be true and correct.

- 23. It is clear from records received the Voluntary Compliance Settlement Agreement language including Slopes data that are materially at odds with language shown from Licensed Surveyors. For example, the City is saying the Slope is 43% whereas the Licensed Surveyors are saying 37%. Note also I spoke with a Washington State licensed surveyor and he has confirmed via email the 37% slope is correct. The importance of this cannot possibly be overstated because > 40% slopes are regulated as steep slopes whereas <40% slopes generally are not. This is precisely why the City has repeatedly including in the Notice of Violation documents declared the slope is 43.8%, even though the Surveyors have proven otherwise.</p>
- 24. Also, there are many other potential issues observed in the VCA, which I need time to explore before bringing to the Appeal Hearing. This is especially true now that new document records have been produced by the City during today via the13 different emails.
- 25. Public records requests have not been produced timely. Given the significance of the Record found via the Surveyor (i.e. Surveyor says slope is 37% vs. City claim of 43%) additional time is necessary to review and determine whether additional or similar records exist and are not provided.
- 26. Disclosure and Due Process are core tenets of a fair legal system. Unfortunately, disclosure has failed since May until possibly this very day. Due Process can only be attained by me with the necessary time to review the new Disclosure.
- 27. Up until today, there has been failure of Disclosure and Due Process whereby significant information asymmetry was forced upon me by the City. It was only due to significant efforts on my part these records were produced today. There is also little or no reason the City could not have produced the records by this time, and in fact I believe the law required production before this time. Six months is a long time to wait.

## CONCLUSION

It is beyond inappropriate for me to have to limit preparation by excluding what appears to be hundreds or even thousands of pages worth of City records that were first made available to me today, which is just days from when I must submit exhibits per the hearing schedule and rules. I have been placed at unnecessary risk failing at the Appeal Hearing due to forced pressure applied unfairly and in bad faith. The City has had since May when #21-300 was properly entered in the NextRequest system, yet the City chose to wait until today to produce the records first received during today. Most likely I would need to withdraw the Appeal altogether as a direct result of the City's actions as well as inaction should the hearing date not be rescheduled as per the points above. See the Exhibits enclosed for evidence. I simply cannot review all the new documents and simultaneously prepare and submit a complete case by November 12 while also working full time and scheduled to be out of town during the coming weekend of November 6. I have four children ages 5, 10, 11 and 12 that depend on me during evenings and weekends. What the City has done to me and my family is bad faith and absurd.
