Dear Mr. Miller:

Thank you for your prompt notification of your son's exposure to COVID-19. I hope your son does not come down with COVID and I hope that neither you nor your wife contract it, either.

I fully understand and sympathize based on my own experience. On November 10 our first grade granddaughter was exposed to COVID on her school bus. She over-nighted with us on the 12th and stayed with us from the evening of the 14th to the 16th. Her school was not notified of the COVID exposure until Monday the 15th and alerted parents on Tuesday the 16th. I picked her up from school that afternoon (she was not allowed on the bus) and took her home. She tested positive on the 17th and her father tested positive on the 18th. Her entire family caught the virus. Fortunately, none had to be hospitalized. For about the next two weeks my wife and I took food to them, put it on the porch, rang the bell, and left! Fortunately, neither my wife nor I caught the virus.

Therefore, I ex parte postpone our Friday hearing.

As you may recall, I am scheduled to have corneal surgery in early February. Friday the 21st was to be my last potential hearing date before the surgery. I do not expect the surgery to be postponed as it will be outpatient at the surgeon's surgi-center, not in a hospital. I will be able to return to hearings the week of February 28. As of now, I am available on March 1, 4, 7, 8, 9, 11, 14, 15, 16, 17, and 18 (for starters).

I regret having to postpone the conclusion of our hearing. I hope that both parties will be available on one of the earlier of my available dates.

I respectfully ask all principal parties to advise me of their date preferences not later than this Friday, January 21st.

Please see below message from the Principal at his school, Mr. Eric Thuau. Note that my son is in the PK-A (pre-kindergarten; A section) class referenced in the email.

Please note that I have just learned about this tracing and associated quarantine impact on our family, and have messaged you and the other party quickly in order to try and provide as much advance notice as possible.

Also, please note that I can be flexible most dates during February for purposes of rescheduling a new hearing date.

Dear PK-A Parents and Faculty,

We are sorry to have to inform you that we received notification that an individual who has been in close contact the entire last week with our PK-A class has tested positive on Saturday 01/15 for covid-19 (the CDC defines a close contact as any individual who has been in the presence of a person or persons with confirmed or suspected covid-19 for a cumulative total of 15 minutes or more over a 24-hour period; additionally, FASPS considers all members of a classroom as close contacts when an individual in that classroom tests positive for covid-19). This individual is in isolation and will be off campus. We wish this individual a quick and event-free recovery.

It is important that we share this information with you quickly so that you can make informed decisions regarding your student's health and wellbeing. According to the CDC, any individual who is not fully vaccinated and who is identified as a close contact should do the following:

- **The close contact needs to quarantine***. The CDC recommends (and FASPS requires) that close contacts who are not fully vaccinated quarantine **for a total of seven days from the date of last exposure (which in this case would be Friday, January 14)**, making their last day of quarantine Friday, January 21. **A negative PCR test is also required before returning to campus.**
- Since PCR tests are difficult to schedule, we are offering our PK-A class the option of participating in next week's Mirimus testing, in other words, feel free to come to campus during the day on Wednesday (January 19) to pick up your child's testing kit, and please return your child's saliva sample on Thursday, January 20, before 10:00am. We recommend the test being done on Thursday morning before 10:00am.
- The close contact should wear a mask if they must be around others.
- If the close contact develops symptoms, they should isolate and get tested immediately.

* Whenever a Tiny YPK – PK class is identified as having had close contact with an individual who has tested positive for covid-19, any students in that class who previously tested positive for covid-19 and successfully completed their 10-day isolation period will not be required to stay home for seven days of quarantine; in other words, students who've had covid-19 and completed their isolation periods will be allowed to come to school — as well as attend Garderie and Enrichment classes — as usual if they are identified as close contacts.
