# I. INTRODUCTION AND REQUEST FOR RELIEF

## III. LEGAL ARGUMENT

The City of Mercer Island Hearing Examiner Rules of Procedure ("ROP") 204 allows any person to file a prehearing motion. Pursuant to ROP 412(c), the Examiner "will grant postponement requests filed jointly by the principal parties[.]" The Examiner should exercise this authority and stay this matter for 30 days.

The Parties believe a stay of this matter will preserve the Examiner's and Parties' resources. There have been no prior stays or postponements. As all Parties agree to this stay, no party will be prejudiced.

If either Party believes the stay should be lifted before the 30 days have elapsed, that Party may move to lift the stay at any time.

### **IV. CONCLUSION**

For these reasons, the Parties request that the Examiner stay this matter by 30 days.
