PUBLIC NOTICE OF APPEAL HEARING

NOTICE IS HEREBY GIVEN that the City of Mercer Island Hearing Examiner will conduct an Open Record Appeal Hearing on the following, which will convene at 10:00 AM on Wednesday, January 25, 2023:

- File No:Appeal Number APL22-004.
- Description: Appellants Stroum Jewish Community Center of Greater Seattle, Island Synagogue, French American School of Puget Sound, Congregational Church of Mercer Island, and Yeshiva High School (collectively, the "Community Organizations") appeal a City of Mercer Island Code Official initiated and issued development code interpretation (DCI 22-004) to clarify:

MICC 19.06.110(B), *Variances,* imposes a hardship criterion that requires applicants requesting variances in residential zones to demonstrate that strict enforcement of Title 19 MICC will prevent the construction of a single-family dwelling on a legally created residentially zoned lot. MICC 19.06.110(B)(2)(a).

Can the City grant a variance from numeric standards for a <u>non-residential</u> <u>structure</u> sited in a residential zone, if under MICC 19.06.110(B)(1), all criteria in subsection(B)(2)(a) through (B)(2)(h) must be met, and that for a variance to lot coverage standards, the criteria in subsection (B)(2)(a) through (B)(2)(i) must be met?
