**Narrative of Ofc. Owen:**

On 06/19/2023 at approximately 0938 hours, I Ofc. Owen #182, was dispatched to an animal call at 7540 SE 71st St, Mercer Island, WA, 98040.

Once I arrived on scene, I contacted the RP: Reiff, Kim, L., (#01/1953), who stated she was walking her dog in the neighborhood. Reiff stated that as she was passing one of her neighbors house, a grey and white Australian Shepard came charging at her and her dog. Reiff stated the Australian Shepard ran through the electric fence that is supposed to keep the dog in. Reiff stated the dog then bit her upper left thigh. MIFD came and medically evaluated Reiff and cleared her.

I then contacted the neighbor: Irvin, Brent, R., (#01/1972), at 7510 SE 71st St, Mercer Island, WA, 98040, who stated his dog ran through the electric fence but does not believe he bit the RP. Irvin stated the dog is very well behaved and acted out of his normal character. Irvin stated he will build a large fence around the property so this will not happen again.

After contacting Irvin, I determined the dog was not aggressive in any way while I was present. Irvin was able to show me the dog listens on command and is very well behaved. I believe the dog scratched Reiff on the upper thigh because there were no obvious teeth marks, and it was a single scratch mark. I believe the dog jumped up onto Reiff where the dogs paws would be level with Reiff's thigh.
