Hi Kevin,

We (Molly, Ryan and I) did have a meeting with the architect/contractor/owner and geotechnical engineer to discuss the marginal rockery issue on the site.

My review comment re: mitigation for the marginally stable west rockery—connected to the south rockery that is in the ROW would likely result in replacement of that rockery with a structural wall. During the meeting the issue of original grade came up which changed the focus from rockery mitigation to establishing original grade.

The original grade issue and your comment re: removal of the rockery from the ROW will require changes to their current plans. Hopefully the project changes also address the marginally stable rockery on the west side.

Thanks for updating me on the ROW requirement to remove the rockery.
