The parking plan included a suggestion that the Thrift Shop parking lot could provide an opportunity for shared parking for evening events. This parking plan—along with all of the materials submitted for review—is still under review, and no proposals or plans in the submitted material have been approved by the City.

Greetings Virginia,

Thank you for taking the time to provide comments on MICA. Please note that the SEPA review currently underway is a review of potential impacts and proposed mitigation measures. It does not authorize any construction or approve a specific design. It also does not provide any kind of "code exemption".

MICA has, however, submitted an application for a Zoning Text Amendment to modify the standards in the zone in which Mercerdale Park is located—a request to change the

code, not get an exception to the code. Zoning Text Amendments require a public hearing held by the Planning Commission, who would then make a recommendation to the City Council. The City Council holds a public meeting and would ultimately make the final decision.
